Nationality Membership I.D Application.

Terms and conditions for receiving benefit: The Moorish Science Temple of America, hereinafter referred to as "the Temple," is a sovereign, Islamic, theocratic government incorporated under the Illinois Religious Corporation Act of 1872, Hurds revised statutes. **The Moorish Science Temple of America is part and parcel of the said government; therefore, it will not serve as a means to escape justice or law enforcement, furthermore nationality with the M. S. T. A. does not cancel the citizenship of any other countries or nation states.** The Temple recognizes and upholds the rights and protections of all individuals, regardless of their religious beliefs, including Muslims/Moslems, Christians, Jews, Buddhists, and others, in accordance with the laws of The Holy Koran of Mecca and a model of interpretation similar to the illustrious Moroccan/Moorish and Ottoman Empires. All individuals who receive Moorish credentials from the Temple shall be considered beneficiaries/holders and shall be subject to the jurisdiction of the Moorish Science Temple of America. The Moorish credentials issued by the Temple serve as a form of identification, proof of citizenship, or registration within the jurisdiction of the Temple. The Temple guarantees the following citizenship rights and protections to all individuals holding Moorish credentials:

a. Freedom of religion: All individuals have the right to practice their chosen religion without interference or discrimination.

b. Equal protection under the law: All individuals shall be treated equally before the law, regardless of their religious beliefs.

c. Right to due process: All individuals shall have the right to a fair and impartial legal process, including the right to legal representation and a speedy trial.

d. Freedom of speech: All individuals have the right to express their opinions and beliefs freely, as long as it does not incite violence or harm others.

e. Right to privacy: All individuals have the right to privacy and protection against unwarranted intrusion into their personal lives.

f. Right to property: All individuals have the right to own, acquire, and dispose of property in accordance with the laws of the Temple.

g. Right to education: All individuals have the right to access education and pursue knowledge without discrimination.

h. Right to healthcare: All individuals have the right to access healthcare services and receive necessary medical treatment from whomsoever they or their healthcare providers and insurances choose.

i. The Temple shall provide consular services and diplomatic protection to its citizens, including assistance with legal matters, travel documentation, and representation in international affairs.

j. The Temple reserves the right to revoke or suspend Moorish Credentials in cases of misconduct, violation of the laws of the Temple, or threat to national security.

k. The Temple shall maintain a system of governance based on the principles outlined in The Holy Koran of Mecca, The Holy Koran of the Moorish Science Temple of America, and the Divine Constitution, ensuring the welfare and prosperity of its citizens.

l. Any disputes arising from the interpretation or implementation of these terms and conditions shall be resolved through peaceful means, including negotiation, mediation, or arbitration.

m. These terms and conditions are subject to change or amendment by the Temple, as deemed necessary for the betterment of its citizens and in accordance with the laws of The Holy Koran of Mecca, the Holy Koran of the Moorish Science Temple of America, and the Divine Constitution.

Obtaining a nationality card does not bestow U.S citizenship.)
